The Seed

While the movement had grown across the length and breadth of the country, we were 35+ locations strong for the helpline volunteers. SIF, till 2014, had listed direct contact numbers of over 100 volunteers across these 35+ locations. Victims of the gender biased laws, crime against men used to reach out to these direct helpline volunteers for help and support.

Helplines were effective from day one as they provided a heart-to-heart brotherhood help in difficult times of the victims.

With the advent of IT systems and the growing demand, we had to undergo transformation, which is where Swarup Sarkar, Wasif Ali from SFF (SIF Delhi) and DS Rao from Hridaya (SIF Kolkata) sowed the seed of the idea of a single number (virtual number) helpline, giving the birth to SIF-One.

What was the Need

- The number of calls were growing, making it difficult for volunteers to manage their professional and volunteering time
- Callers were missed as it was difficult for each volunteer to keep track of all calls
- In spite of supporting thousands of callers, it was difficult to present the gamut of discrimination we were supporting because of absence of a centralized system
- Centralized system of SIF-One resolved load on every volunteer through its special randomizing feature
- Centralized system of SIF-One improved situations of unanswered calls as each call rings with multiple volunteers for selected extension
- Centralized system of SIF-One gave us clear data on the caller's source and destination, without compromising anonymity, giving insights on geographies of strength and geographies of improvement
- Centralized system of SIF-One also helped in easier rotation of volunteers to allow us grow our teams and enable better support without burning out our teams
- Centralized system of SIF-One added additional level of data security and anonymity where the identity of both parties on a call, along with their phone number were masked from each other

BIRTH STORY

Dates

It was 14th of April 2014 when SIF-One was officially handed over to SIF from our proud partner and service provider after careful selection of the virtual number i.e. 8882498498. Since the birth of the movement had IPC 498A to it's core, the number had to refer to the very roots and hence this number was finally selected by the core working team, which had SPOCs (Single Point of Contacts) from each region.

Next 36 hours were crucial for our admins and SPOCs to login, test, check, QC the complete system and platform. Continuous & multiple testing were conducted by the SIF-One volunteers, SPOCs, admins, including checking the data collection and doing away with any services from the service provider/partner which could compromise the anonymity of the victim, the core value we stand for.

Two internal, quick communication WhatsApp groups for SPOCs (21st March 2014) and for Volunteers (28th Feb 2015) were created for enabling immediate discussions, inputs.

Another sub-committee of SPOCs started working on the creation of an internal Do's and Don't's, which underwent iterations, developments and improvements. Every volunteer joining SIF-One is trained on these Do's and Don't's by respective SPOCs/Admins.



The Launch

It was 14th April 2014, is when, SIF team conducted Press Conference in Indore, Madhya Pradesh and that's where the first official announcement and press release was done by Save Indian Family followed by series of Press Conferences and awareness campaigns to spread the "SIF-One: Helpline for Men: 8882498498" were conducted across all SIF's chapters, NGOs.

Media also supported and picked up the news articles, resulting into publishing of the helpline number in major regional dailies.

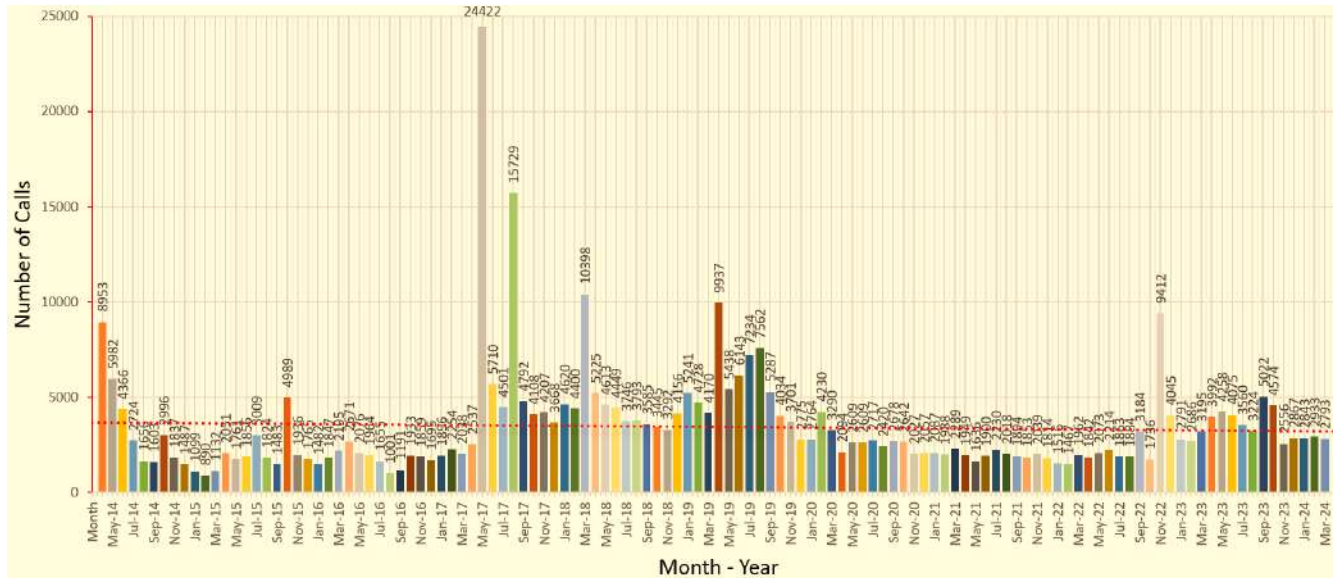

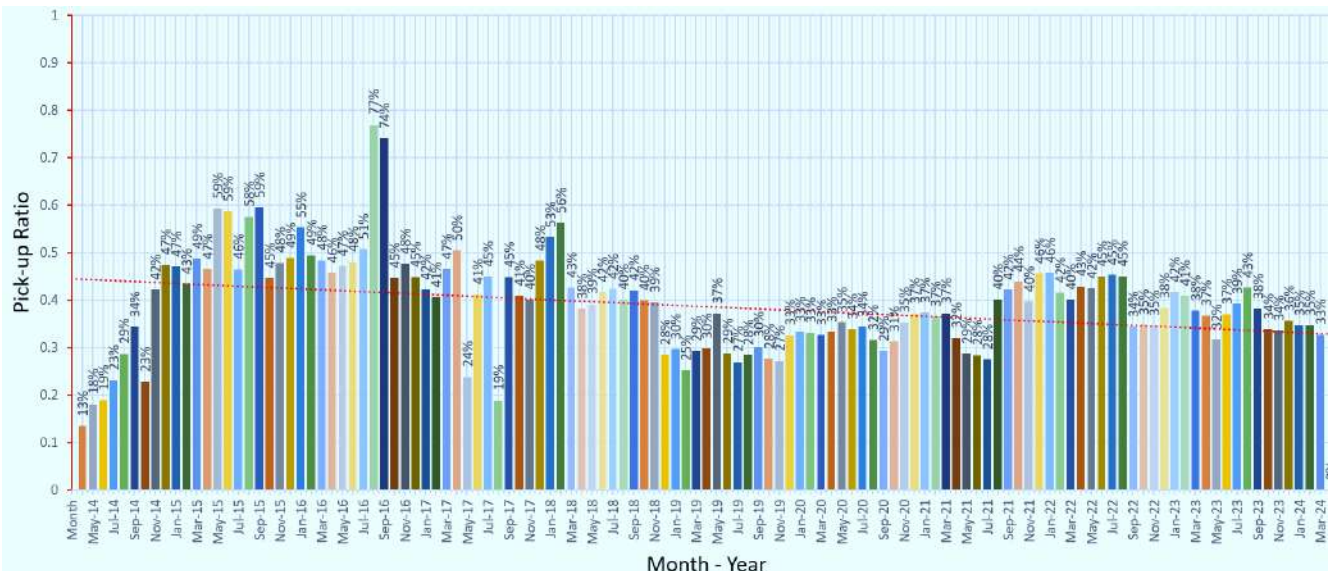
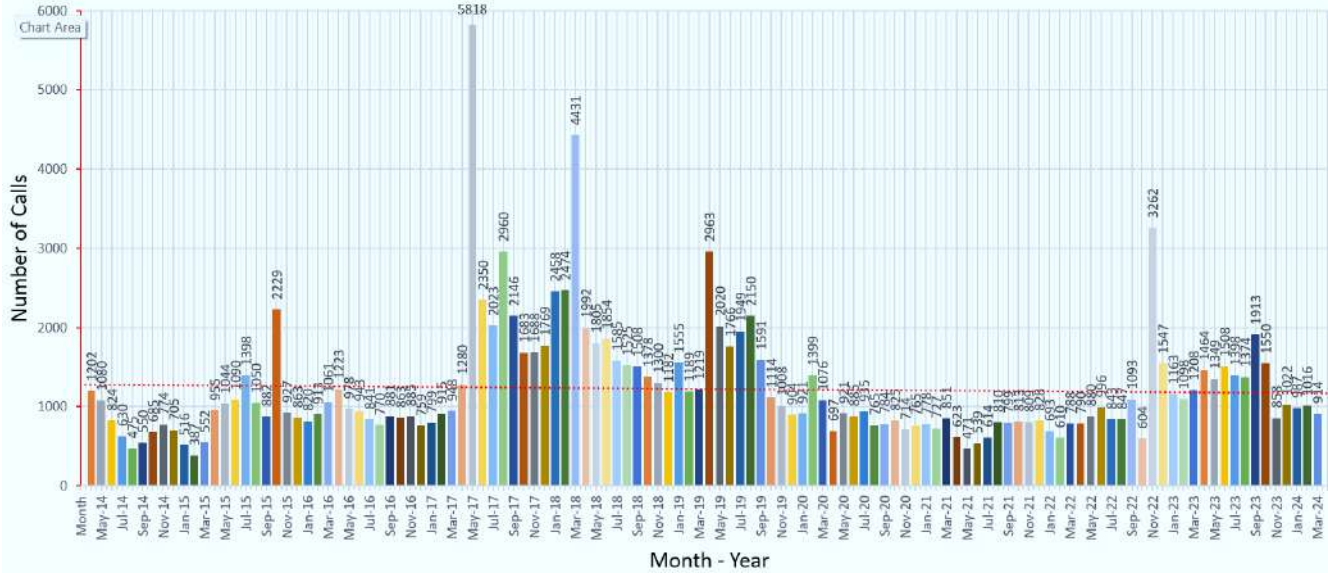
- May 2017 is the month which received the maximum number of calls in a month
- The peaks achieved monthly are a result of either mainstream media publishing the helpline number (in Karnataka, in October 2015) or Social Media posts going viral (in Delhi, in November 2022)
- Lockdown period had the least number of calls as men are even more scared to reach out for help while being physically in same place as their abuser

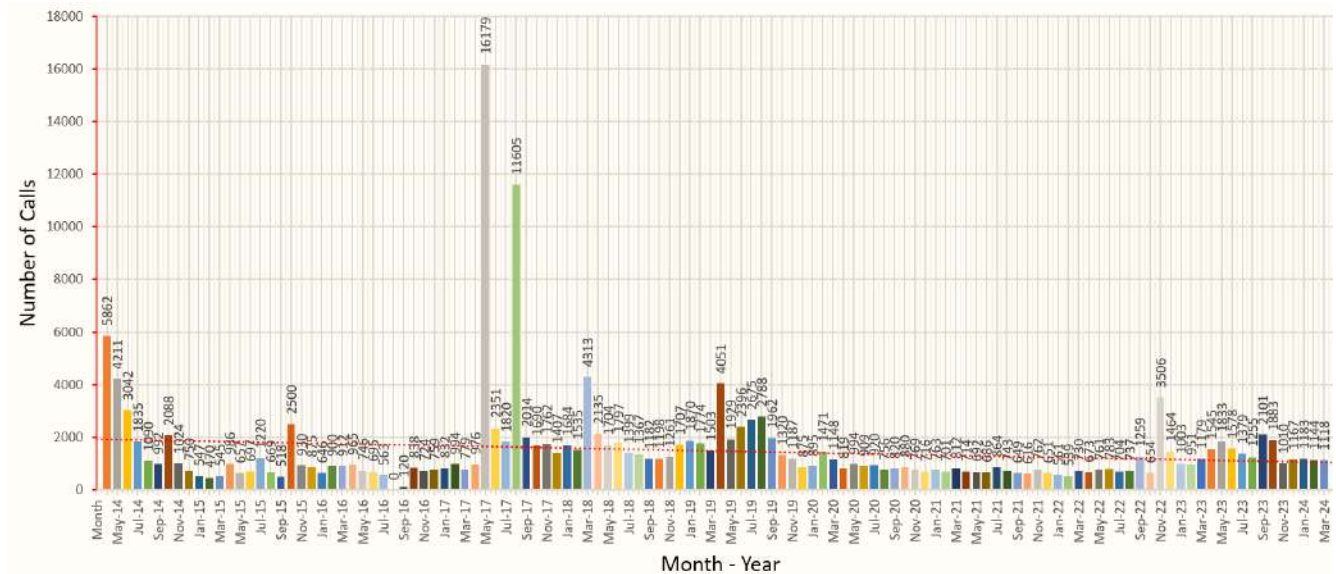
- Average pick-up ratio has been about 36% over past 10 years

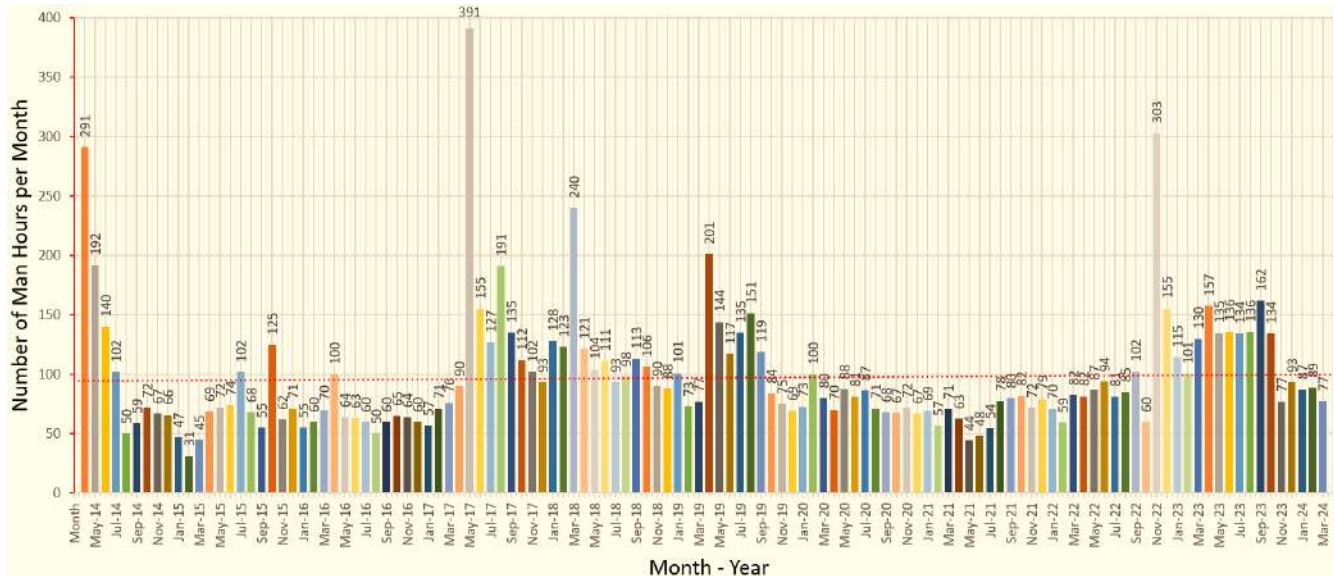
- SIF-One allows us to cater to missed calls and voicemails under separate heads

- 2021 (covid year) & 2016 clocked about 780 hours of support calls, the lowest

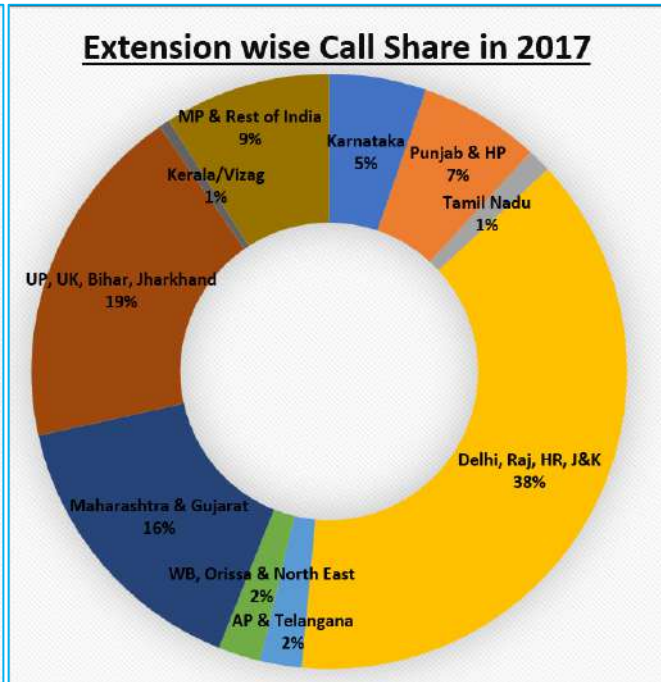
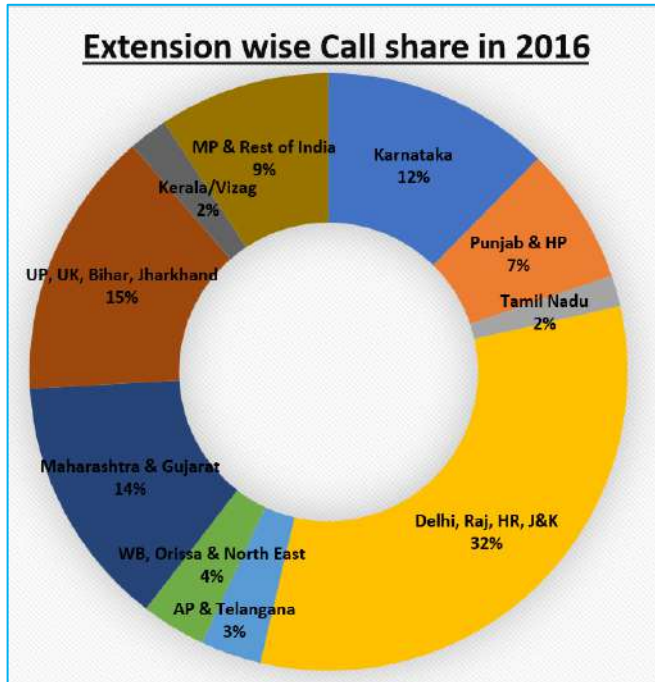
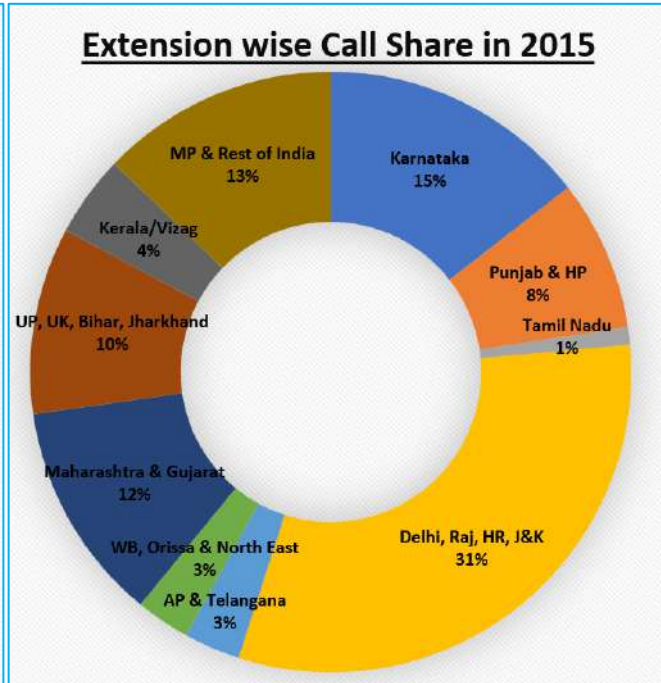
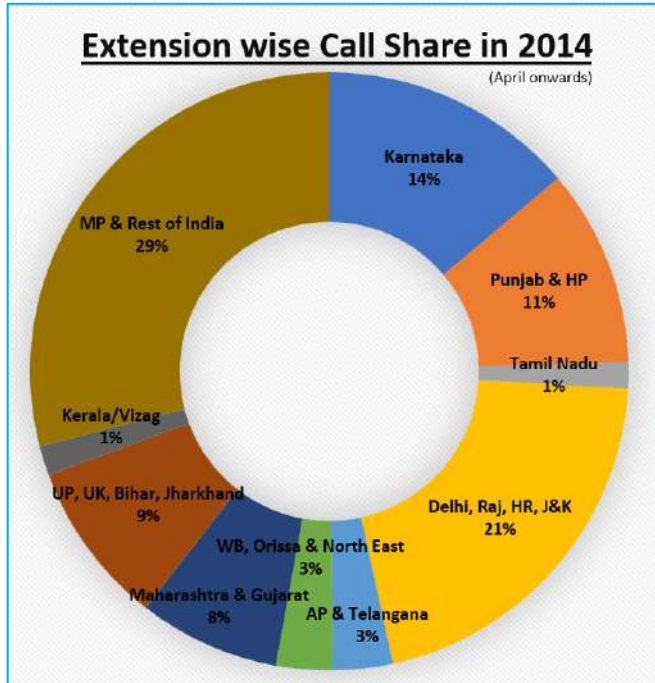

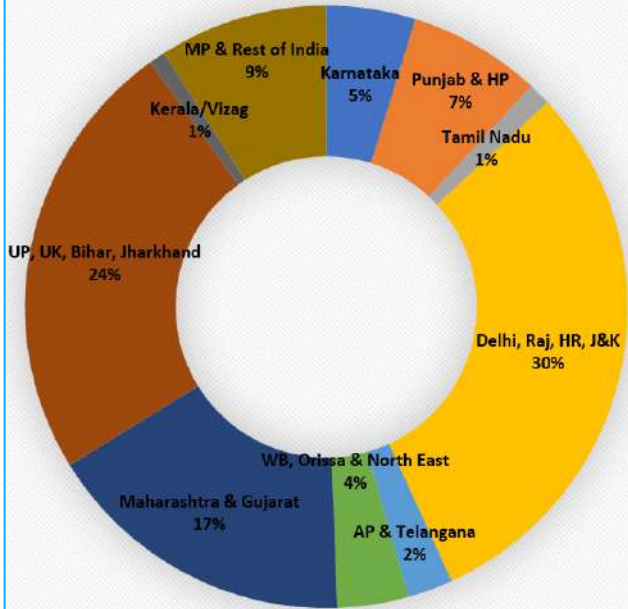
Extension wise Call Share in 2018



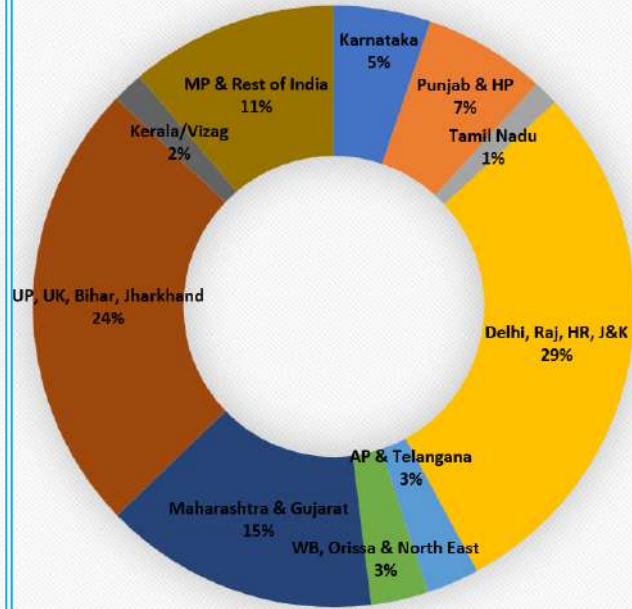

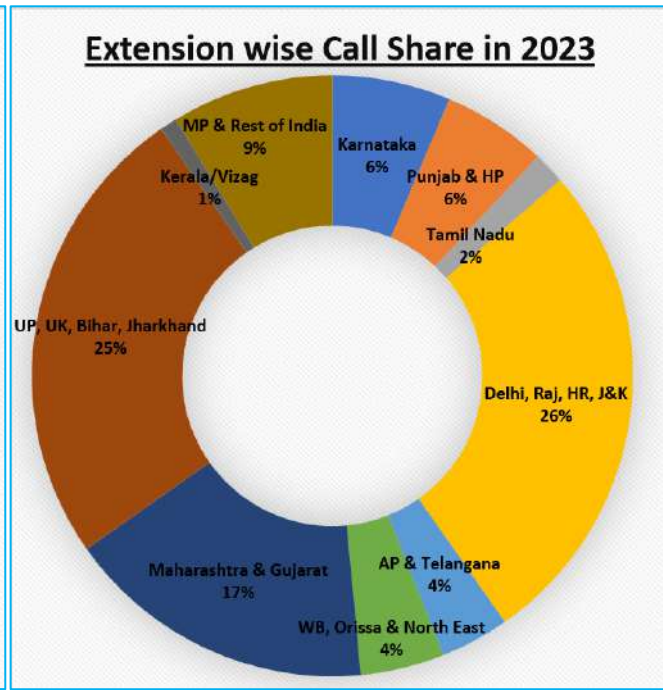
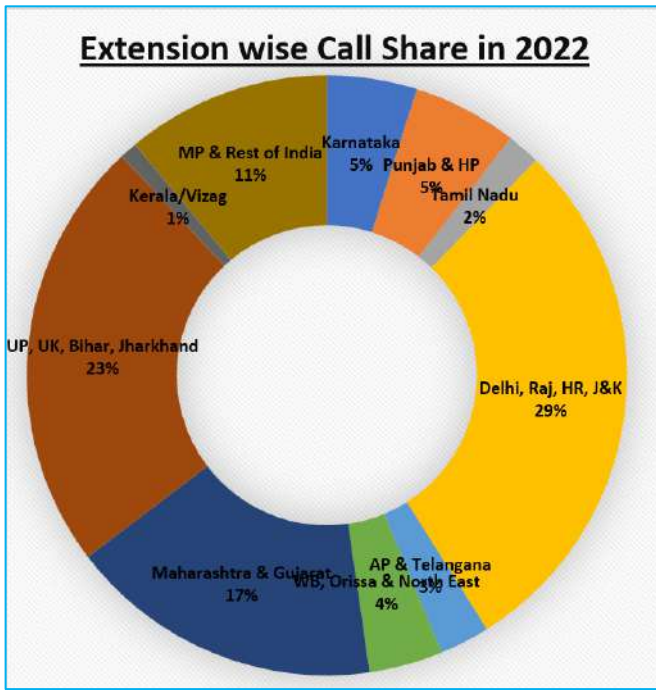


Extension wise Call Share in 2020

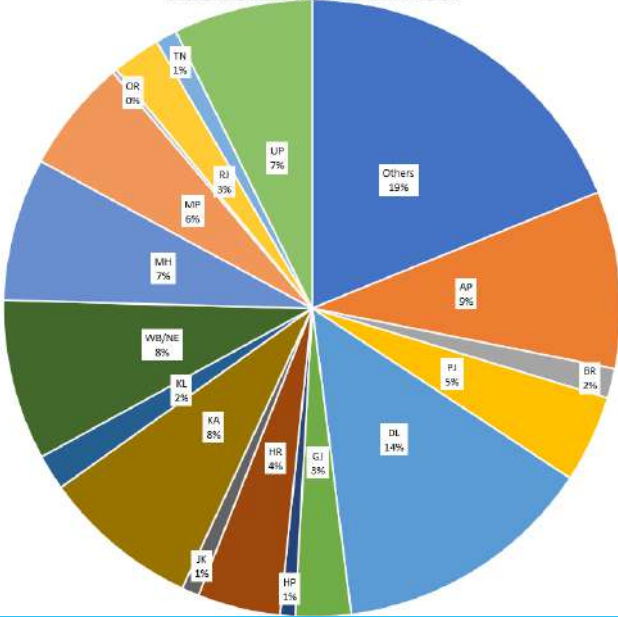
Caller Location spread in 2016



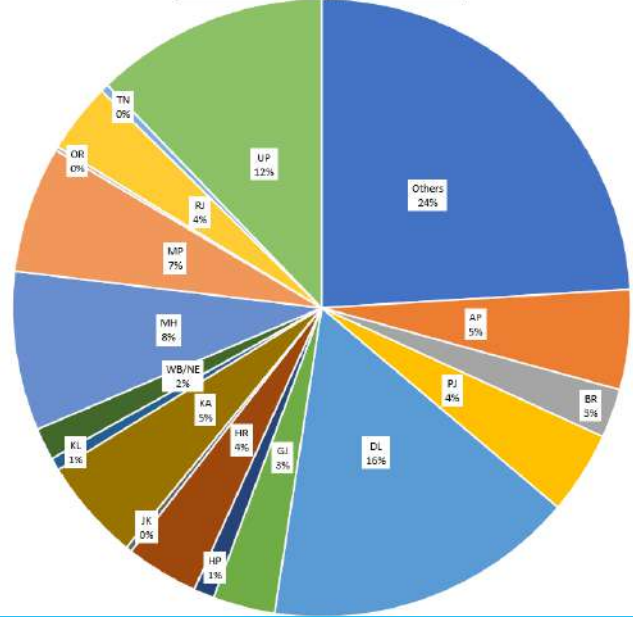
Caller Location spread in 2017

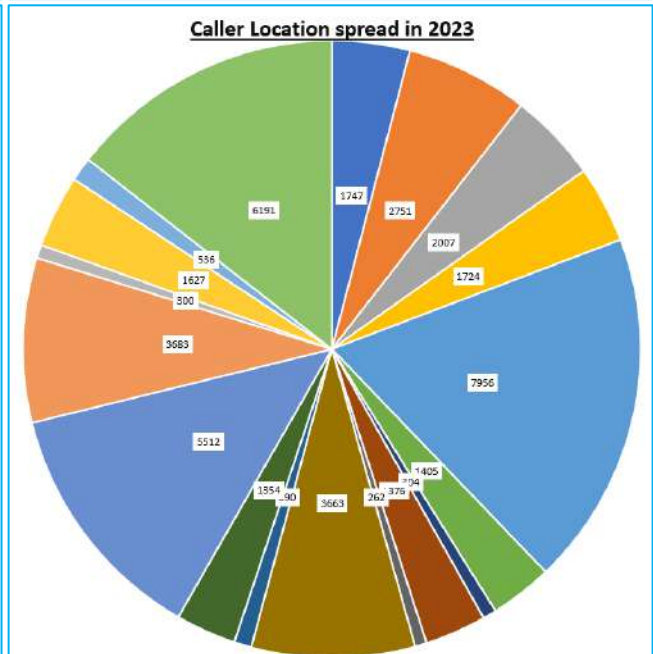
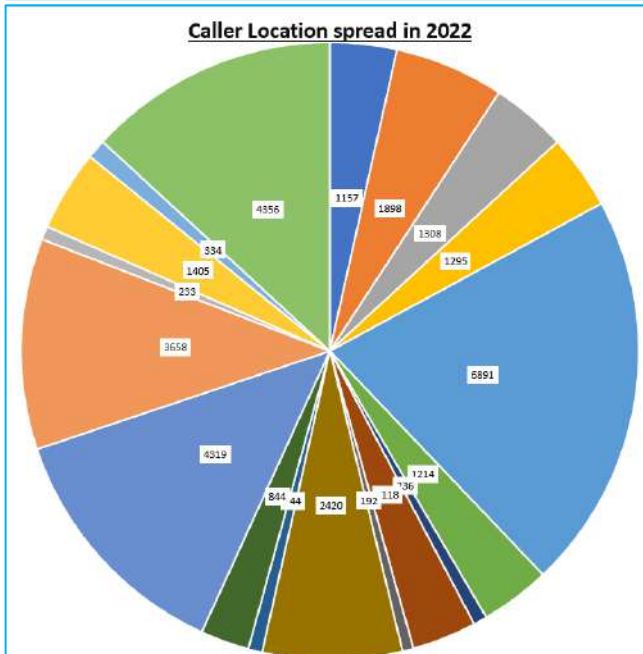
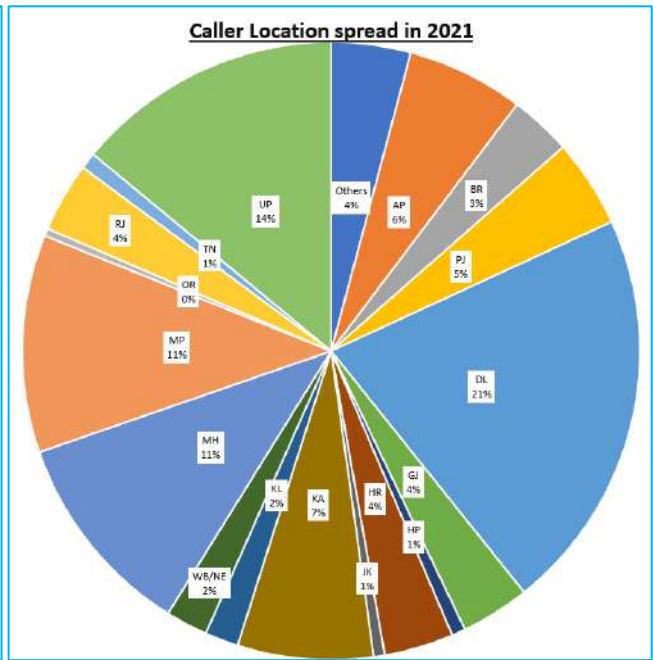
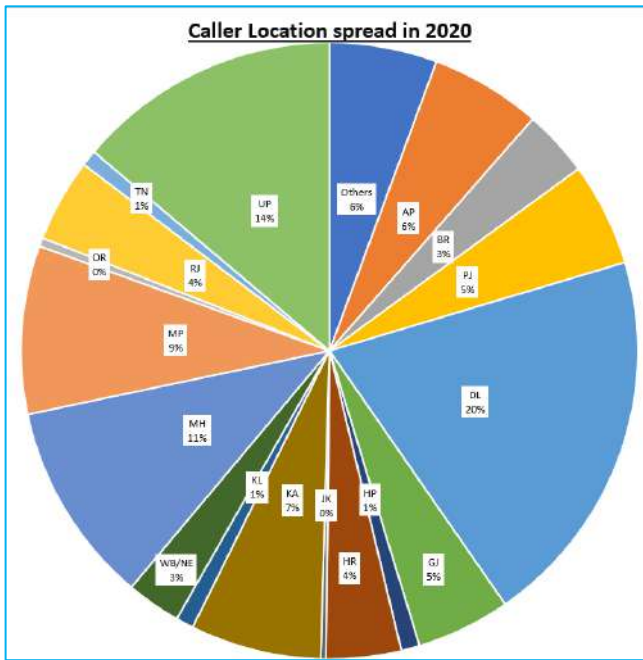


Caller Location spread in 2018

SIF One (0-8882-498-498) – HOPE FOR MEN

SIF-One (0-8882-498-498), it's single number access to the World of Help for men. When it was launched on 12th April, 2014, we targeted to be able to help men when in distress, would be able to help men who are victims of misuse of gender biased laws.

Few known data points were always an indicator of the Anti-Male sentiments that men face in Indian Society. Below data points, which were never pondered upon ever before were:

- As per National Crime Records Bureau (Ministry of Home Affairs) data, over 64000 Husbands commit suicide every year.
- Hence, as per N.C.R.B., one Husband commits suicide every 8.3 minutes
- As per N.C.R.B., Husband suicide in India is double to that of Wife Suicide (including alleged 304B cases).
- Approx. 98% of total Dowry Harassment Complaints filed (IPC 498A intention complaints), are not found either worth of conviction or even filing FIR or Chargesheet.
- The threats and misuse of Rape Laws has become equally rampant with Court data putting it to as high as 72%. Many Courts have indicated this misuse.
- We have found that misuse is not limited to Metros or Cities but also in rural areas and villages.

SIF One received about **16,000 (SIXTEEN THOUSAND) calls** in **less than 50 days** which really showed one thing that trauma of men was just not about being victims of Gender Biased Laws or of Misandry in the society, they are also big victims of delayed justice which meant that SIF's initial estimate of over 2 Crore victims across India of Gender Biased Laws was conservative.

SIF-One helpline showed some shocking analysis on the how useful a men helpline can be:

- SIF-ONE GETS ABOUT **16000 CALLS IN 50 DAYS**
- SIF-ONE GETS ABOUT **20.5 CALLS EVERY HOUR (16 hours a Day) OR 330 CALLS EVERYDAY.**

Men being Raped, Men being Gang raped and these crimes being done by Women is a reality which is not talked about, lesser discussed about and least believed. But society's bias against men doesn't bring down the rate of Crime against Men. Few latest report reveals some of these facts like:

1. As per UNICEF, out of 69% children are physically abused in family situations in 13 sample states in which 54.68% were boys <http://www.india.com/india/child-abuse-in-india-8-children-physically-abused-by-their-parents-1111210>.
2. The national study had also reported higher incidence of child sexual abuse in boys at 52 per cent against 47 per cent girls becoming victims of child sexual abuse <http://www.bhaskar.com/news/child-sexual-abuse-of-boys-exceeds-girls-in-national-study-11411210>.
3. The Delhi-based Centre for Civil Society found that approximately 18% of Indian adult men surveyed reported being coerced/forced to have sex. Of those, 16% claimed a female perpetrator & 2% claimed male perpetrator <http://www.zeenews.com/india/indian-adult-men-reported-being-coerced-to-have-sex-11411210>.

Now, with various reports talking about sexual abuse of boys and data related to it, do we feel that suddenly, after attaining 18 years of age, boys, considered as men, are not sexually abused / exploited?

SIF One (0-882-498-498), the single number helpline for Men in India, had counsellors face lot of these real life incidents from victims. Without disclosing the identity of the victims, SIF One counsellors have come across numerous cases of Men and Boys being Raped and Sexually Assaulted. These heinous crimes against men are over and above the other major crimes like Stalking of Men, Acid Attacks on Men, Indecent advances on Men, Groping, Touching, Filming etc. etc. of Men which goes unnoticed as Law and our Feminist minds don't even identify these. As a result, Men are going into severe depression and thus affecting the youth of India. Which means, the very Engine of "Development of India", is undergoing severe depression & increasing suicides <http://www.bhaskar.com/news/india/indian-adult-men-reported-being-coerced-to-have-sex-11411210>, thus threatening the country's growth itself.

In one of the calls of 24500 calls, counsellors got call from a boy who was gang raped brutally by a gang of 4 women who were in their 40s. Infact, the boy was taken through role-play of being a slave which left him sexually and physically tortured. This incident has left the boy completely suicidal and with no hope left to live any more. But unfortunately, he does not have a legal recourse of being victim of Rape. Counsellors helped the boy to atleast get out of isolation and suicidal tendencies. But counsellors felt crying for the apathy that the Law of this country shows towards atrocities done to men. Boy had recently celebrated his 18th birthday and hence counsellors could not advise him to file a complaint under POCSO. Infact, his calls to Government's Child helpline gave him no response for the same reason.

Another caller, a domestic helper was sexually abused for over 6 months by his lady employer which developed infections in his genitals. Since the pain of these infections dint allow him to do any work, he was kicked out of his job by the same employer. With no money to have food and no place to live, the counsellors gave him some solace by helping him find a new job through an employment exchange of the Government. Though some part of his pain was eased, his real abuse, yet again, went unnoticed, as, HE IS A MALE.

Similarly, Protection of Women from Sexual Harassment at Workplace is hounding the corporate world. The counsellor of SIF One on an average get 10 calls every week pertaining to Sexual Harassment of Men at workplace. The Law, which does NOT protect men, leaves them with no choice but to keep getting sexually exploited by female bosses. Only other options left to them are either to leave the job or to end their lives. Leaving the job for the bread-earner of the family means, the family will be left with no food to eat. But while drafting the law, the Law makers, conveniently ignored 87% of workforce, i.e. Men.

It was April end 2014, when SIF One – Hope for Men, was launched in 9 locations across India. Soon, a simple and humble start of a National Helpline for men, started getting unprecedented number of calls and huge amount of Heart tearing facts about value of a Man's life in India. SIF One counsellors, each of who is himself experienced of helping 1000s of Men across India, thought that they have witnessed the worst cases till date. Then came the calls from SIF One and SIF One counsellors realized that what they had heard or seen in few cases, or even worse, was the situation all around. Because of SIF One, victims of Gender Biased Laws misuse, victims of Misyandry in society, got courage to speak to someone who could help them, support them, ease their pain, motivate them to fight and see through their fight to get their lives back.

Over past 1 year, few notable moments / cases which opened even our eyes wide open were:

- Call from a 19 year old boy who was gang raped by a group of women of age ranging from 30 years to 45 years. He was raped for hours, filmed nude, beaten by leather belts, objects inserted in his private areas, urinated upon and forced to do many such inhumanly acts, against his will. Counsellors were pained and brain stormed a lot on what legal recourse he has as he had crossed the limits of POCSO Act and Rape law doesn't allow him to be a victim. He is even today, lives under constant threat of false Rape case being filed on him by the same women.
- Call from a Heart-Patient, 76 years old father, whose only son was burnt alive by wife and in-laws at in-laws place. The son died after suffering 95% burns and struggling for life for 5 days in Hospital. The father or family members were not allowed to ever meet with burnt son for 5 days while his wife & in-laws took his false finger prints on a suicide note. The father, while was getting his Pace-Maker surgery done, was made accused in a false theft case by Daughter-in-Law for which he was arrested. Blood boiled hearing this ordeal but as a Counsellor, we provided all the procedural and legal knowledge to the family members. But then, counsellor knows, afterall, it is a Groom Burning case, so no body in India is interested in it.
- Call from a widow mother, whose only son committed suicide because of a false Dowry case and threats of jailing him and his mother. While this old mother was near to cremation ground as her only son's 'ANTYESTI' was being done, her Daughter-in-law entered the house, threw the articles of Mother-in-law out of the house and occupied the house. Now, the old widow mother of this son, who was pushed to commit suicide by his wife, has no place to live and her complaints to various Women Supporting groups have not got her any help yet.
- Call from a son whose Mother was beaten up by his wife to the extent of life threatening injuries. The mother was lying in the pool of blood and is being treated for injuries. When complaint was filed to State Commission of Women on her behalf, the State Commission of Women replied that they do not take complaints by Mother-In-Law against Daughter-In-Law.

These few calls of over 38000 calls received in 1 year of SIF One tore us apart and tore our understanding of the term Humanity & Women Empowerment. We witnessed humungous misuse of just not IPC 498A (Dowry Law) but even worse misuse of Rape Laws, Workplace Harassment Laws, Custody Laws, Maintenance Laws, Divorce Laws etc. etc. Though, it gave us 1 motivation. Motivation to ensure that SIF

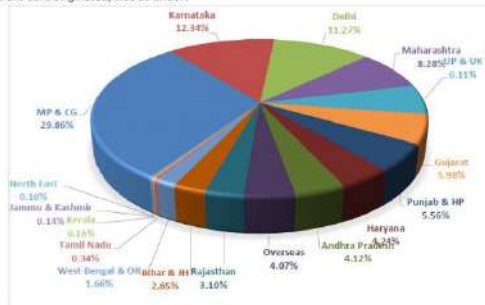

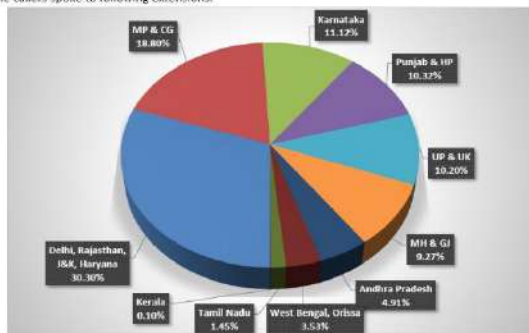

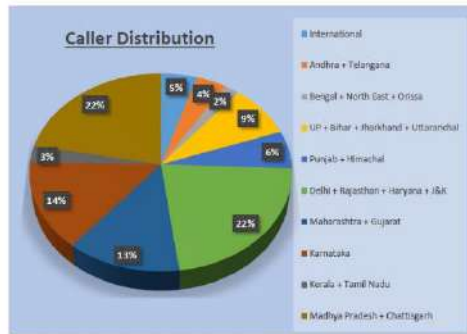

Below is the analysis of calls received on SIF-One from 1st Jan 2020 till 26th April 2020. For analysis purposes, we have kept the comparison of calls in April 2020 (Lockdown period) as against the call data from 1st Jan 2020 till 31st March 2020 (as pre Lockdown period):

- Total Number of calls received during 117 days (1/Jan to 26/Apr) was 12053
- Average Daily calls Pre-Lockdown (1/Jan to 31/Mar) was 113 calls per day
- Average Daily calls during Lockdown (1/Apr to 26/Apr) was 68 calls per day, reduction of 40% from previous months
- Common Extensions shows least reduction of 38% of calls per day from Pre-Lockdown to after Lockdown
- Tamil Nadu shows the highest reduction of calls from Men in Distress because of Lockdown i.e. 72% reduction
- Extension of Delhi/Rajasthan/Haryana/J&K shows the highest reduction in terms of absolute monthly calls. Pre-Lockdown of 710 calls a month has reduced by 56% to 313 monthly calls post-Lockdown
- Another Huge reduction in terms of absolute calls was seen in UP/Uttaranchal/Bihar/Jharkhand extension by 40%
- Reduction was also seen in Karnataka by 52%, Punjab & HP by 50%, AP & Telangana by 50%, West Bengal/Orissa/North East by 45%, MH & Gujarat by 59%, Kerala by 65% & MP/Chhattisgarh by 55%

Above data clearly states that when Men are unable to get seek help and support while being at home. When they were going out, they were able to get some alone time to be able to call our Helpline to seek help.

This clear establishes the fact that it is Men who are under grave threat at homes and are unable to even seek support. Unlike Women, Men don't get any gender budgets from Government of India to get support. Laws, System, Budgets, are all against Men in reality. The effect is showing up on our Helpline call data.

We Anticipate or rather fear that this may effect Men's Suicide & Survival even more this year. Let's all come together and pledge to #MakeHomeSafe4Men & also to End #DomesticViolenceOnMen

We only hope that crimes against men stop immediately and we, as a country, start treating a crime as crime and not based on Gender.

In one such call on our Helpline, Rajesh (name changed) from Mathura shares his ordeal of series of Domestic Violence and Cruelty done to him. After being forced to leave his ailing parents, to get some peace for his family members and himself, he stayed in a separate house for past 21 years. Having suffered through the 21 years of cruelty at the hands of his wife, Lockdown happened to India. He was forced to work from home where his wife, in addition to ongoing cruelty, has also started abusing him as adulterous person, when he is on official conference calls, including female colleagues. She also hides her office resources like Laptop making him beg for it, as otherwise he may lose his job. She makes him do sit-ups just to enjoy seeing him in pain for handing over the laptop. She even threw boiling tea on his face, which he had prepared for himself. Rajesh, when he calls 100, Police doesn't believe him. He can't go to police to file a complaint during Lockdown and he fears for his life, especially during these aggravated assaults, during this lockdown. 3 days back, his wife and daughter, beat him with sleepers and sandals (with heels), which left him bleeding, thrown outside his own house, for the whole night.

Police said that the woman was allegedly having an extra-marital affair with her cousin and colluded with him to commit the crime. HE was gang-raped, filmed nude, thrashed with belts, and objects were inserted into his private parts.

"Then they urinated on me," the 19-year-old (name withheld) broke down, narrating his story to a helpline recently.

Given that Delhi is widely touted as the rape capital, this should have been just another statistic. But there's a catch. The caller's alleged tormentors were women, and all nearly twice his age.

In spite of being from an influential political family, the caller had no legal remedy. Counselors had a tough time trying to figure out how courts could help him. To their dismay, they found that the Indian rape laws did not recognize a man as a victim. Being an adult, he could not have sought help under the Protection of Children from Sexual Offences (POCSO) Act either.

The 19-year-old isn't alone. Overturning their male ego, stigma and conditioning, hundreds of men across the country are making that call to the helpline with regulations, alleging that they were harassed, abused and victimised by women.

The 8882 498 498 helpline for men in distress, run by 41 NGOs across states, claims to have received 37,000 calls since it was launched a year ago.

Save Indian Family is a worldwide support system that caters to Indian men in distress. The strength of members has risen considerably and has now spread its reach to state groups. Based on the observation that India has become a society which is highly in favor and leaning towards Women, SIF counsels and helps Indian Men across the globe against these Gender Biased Laws of India. In India every 6 Minutes a man commits suicide which is 240 Suicides a day. SIF-K is directly contributing towards reduction of male suicide by running a All India 24/7 helpline (08882498498). It has represented to many institutions and seeks to protect the Human Rights of Men. The following is an excerpt of the interview with the counselors of Save Indian Family Karnataka :

"First they laugh at you, then they ignore you, then they fight you, then you win!" - Mahatma Gandhi

1. To begin with, what is the scope of work of your NGO?

Society treats men as tough and expects them to remain tough come what may. This is traditionally how we bring up our boys and men. This however brings a Man with tremendous pressure to earn and continue his "manhood" by being a mechanical protector and provider alone, without the stereotypical feminine behaviour of complaint or expectation. Men are deprived of basic human rights of being heard, being presumed innocent till proven guilty, being respected, being counselled when in a socio-legal situation. The hopelessness arising out of this situation often turns a Man depressed, tormented and derelict in their lives. Many commit suicide.

The scope of our work is to provide such Men - Hope, counselling and support to exist with honour and exist peacefully. Men have right to peaceful existence!

2. Domestic violence against men as compared to domestic violence against women is a subject that has not been given much attention. Why do you think that is?

Social conditioning shames a Man when he is abused physically, sexually, emotionally or economical by a woman, be it his wife, sister, mother, girlfriend or even a colleague at work. With these conditioning men are heavily reluctant to even acknowledge the violence they suffer. Problems of Men are seldom brought forth or even given a status of social importance for that matter. In this scenario the law making agencies consider the violence against women as the only problem, hence the bias.

3. There are opinions that men's rights groups are misogynistic. What are your views on this?

It's like saying Chemotherapy is anti-human cells. Men's rights groups are against the bias the Men face. When this bias is seen in courtrooms by way of law misuse by unscrupulous women, MRAs (Men's Rights Activists) heavily come down upon laws which are made with the assumption all women are saints and all men are demons. The first half of the previous statement is what, at times, confers on us the label of Misogyny. However it is not true. The MRA community consists of many women who hold esteemed positions in the movement. The MRA have women as their sisters, mothers and spouses too.

4. Lastly, do you think that men's rights groups are overlooked? If yes, why? If no, why?

"First they laugh at you, then they ignore you, then they fight you, then you win!" - Mahatma Gandhi
We as Men's Rights Activists have almost past the first phase when people laugh at us, few still do, some seem to have been silenced. But yes, we are in the second phase for sure - when they ignore you. Ignoring someone or something (intentionally, consciously) is actually a passive way of acknowledgement. As to why we are over looked?, Please refer to the answer we have provided for Q1.

The following guidelines have been compiled by asking for suggestions from SIF One Helpline Counsellors. Some of the points have been edited or fine-tuned by Partha, Nishu and Wafiq in order to clarify, grammar and language.

The guidelines must be followed by every SIF Counselor. The responsibility lies with the respective city's moderators to ensure that these guidelines are being followed to the dot by the counsellors. This will help us with consistency and prevent any confusion.

Amendments:

- 28 October 2014, SIF One Helpline, three calls are sent to counsellors
 - Earlier the calling feature was round robin. The system called one counsellor after another in case there was no answer. The issue with this system was the extended period the caller has to wait before reaching the counsellor. This resulted in the caller disconnecting, in turn resulting in a lot of missed calls.
 - The system has been now been amended to make parallel calls. With this system, all the counsellors are called at the same time and once the call is picked up by any one of the counsellors, other counsellor's phones will stop ringing. This will help in faster answer times and in turn, less missed calls. This system is already implemented and no action is required by the counsellors.
- Added counsellor's numbers from all SIF Chapters. If the person is from calling from another state, you can refer to the numbers listed below and direct the caller to that particular city. Comprehensive list at the bottom of this document.

Do's:

- Try to keep the duration of call within 4 minutes. If the call seems to be exceeding 4 minutes, ask the caller to call you back on your personal number or ask him to call back the nearest city counsellor direct numbers.
- Ask for name, location & relationship to victim. DO NOT insist if caller wants to remain anonymous.
- Use parliamentary language.
- Ask to read Pre or Post 498A survival guide a few times. Tell them this can be found by searching on Google.
- For Pre-498A, stress on Anticipatory Bail and avoid the court in granting the AB by stating that 498A is termed as legal terrorism by SC.
- Tell them that non-bailable means bail in court and does not mean compulsory jail for 3 months.
- Attend local meeting as soon as possible and continue to attend. Local meetings have more legal knowledge than the lawyers. There is a lot to be gained about local judges and systems.
- Tell the caller that we do not charge any money for support. If anyone from SIF-ONE charges money, ask the caller to inform us. Advise any victim like you and I. We want to cleanse society from misuse of gender biased laws.
- If location is near any SIF chapter city, ask him to go & attend meeting. Give him specific details of location & time. (Details Below)

- If caller wants to share his issue on the phone, ask him to explain in brief and not to go into detail.
- If the caller goes into too much detail gently interrupt him with some question like - present status of case, does he need any urgent advice (before the next meeting date) etc.
- After the interruption, tell him that he & his family is not alone & that thousands of families have suffered before him. Most of the victims like us are common law abiding people etc.. This will help the caller to relate to the group better and give encouragement to the caller to attend the meeting without fear.
- At this point it is a good idea to tell him that thousands have also come out successfully from these cases.
- Inform him that 95% of 498A cases end in acquittal.
- Tell him that it is not a good idea to compromise by paying money. We will help them in fighting but not for compromise with financial settlements.
- In case of impending arrest or CNR negotiations, tell him not to panic. Also tell him to be polite with police & also not to reveal any strong evidence he has got.
- If in pre-498A stage, ask him & his parents to write letters to police authority above DDP or DCP rank, PM and Home Min, Supreme Court, NRC saying that they are apprehending undue action against them. If possible, they should go & meet the official also.
- Also ask him to record all calls, collect all documents, photographic & videographic evidence. Try to keep it in original media.
- Tell the caller not to trust anyone relatives, friends, with either evidence or with personal details of cases. Crucial information to lawyers should be given on a need basis.
- Collect and keep evidence like Code of birth, passport entries, rent receipts, power & phone bills, emails, salary slips, homeowner photos etc.. to be kept in a safe place.
- Tell him, it is generally not a good idea to file for Divorce or RCN.
- State the disclaimer, that all advice or suggestions given over helpline or group meetings are general guidelines & that he must apply his own judgement & he himself is responsible for the outcome.
- Ask the caller if he has spoken to anyone else in our city or a different city.
- Ask them to visit and join SIF yahoo groups and forums to increase their own knowledge & to develop their own strategies.

- Tell him never to get scared in the police station and do not give anything in writing in PS or women cell. Do not be scared to call up 100 number if he is being unnecessarily prosecuted. Also tell him to approach Human Rights Commission and tell them what is happening in case of police harassment.
- Tell him to Research a lawyer well before appointing him. Never go with a lawyer who doesn't tell you how much it's going to cost to fight the case.
- Tell him that Media organizations have no legal power nor they can affect cases later in anyway.
- Tell him Mediation centre cannot force men to take the woman back or paying any amount.
- Tell him Change will only come if we fight shoulder to shoulder against these laws.
- Remember that you are a helpline operator and not a service provider.

Don'ts:

- If you cannot attend the call, ██████ cancel/transfer the call. Canceling or rejecting the call will make it go to the external hence let the phone finish ringing and then the system will automatically re-route the call to the next counsellor in line.
- Don't recommend lawyers.
- Don't give any legal advice on SIF Helpline.
- Don't give advice if you are unsure. Tell them to call local chapter helpline or attend meetings for detailed discussions.
- Don't ask them to file any cases initially, specially divorce or RCN.
- Don't tell them that we are legal experts and don't give any guarantee on the outcome of the cases.
- Don't agree to assist him with mediation or personal visits or media coverage. It is up to the person to fight his own cases.
- Don't tell a person that they are crazy, stupid or any other negative words. Remember, they are both in cases and bound to do a few stupid things. Guide them but do not belittle them. Remember that we were at the same stage at one point of time. Don't use negative or abusive language.
